Rules/Guidelines

- 1. Female entrants, born female.**
- 2. Other than two earlobe piercings, any piercing must be removed before the pageant/appearance.**
- 3. All information and photos submitted become the property of the Martin County Fair Association.**
- 4. Once the packet is turned in, no revisions may be made unless requested by Pageant Superintendents.**
- 5. Names of applicants will not be released to other contestants.**
- 6. Two entrants per age category must hold specific titles. If there is a limited number of contestants in one particular age category, Pageant Superintendents/Board in charge of the Pageant have the right to remove/combine age categories. If the age category is removed, the entrant will be contacted, and application fees will be refunded.**
- 7. Entrant will be placed in the age category based on their age on the day of the pageant. A birth certificate is required for proof of age.**
- 8. The entrant agrees to pay the entry fee in full for the application. Payments are made to the Martin County Fair Association. Cash, Check, CC, or Money order, money orders must be made payable to the Martin County Fair Association. Contestants may obtain sponsors other than family.**
- 9. ALL fees are non-refundable.**
- 10. Entrants, families, and affiliates agree that the judge's decision is final.**
- 11. Martin County Fair Association, Pageant Superintendents/Board in charge of the Pageant, nor the Venue are responsible for any items lost, damaged, or stolen.**
- 12. All entrants must have a legal guardian present during the competition. 2-3 year olds require a guardian present on stage with them.**
